**RE: COMPLAINT Against Friends of Mark M. Gillen – Committee # 2010117**

Dear Commissioner Marks:

I hereby formally request an **immediate inquiry/investigation of inconsistencies AND ask for appropriate penalties including criminal penalties if intentionally violating the Campaign Finance Law** as related to Cycle 5 Campaign Finance report submitted on behalf of the following Political Committee:

**Friends of Mark M. Gillen – committee # 2010117**

There is what seems to be a purposeful and misleading discrepancy between the “official” campaign finance report submitted to the Department of State and the “copy” of the report submitted to the Berks County Board of Elections.

Specifically, the following line items from Schedule I are different on the two reports:

Number 2 – Part A - **\$500 in donations omitted from the DoS report**

Chamber PAC - \$250 on 6/27/2018

Timber PAC - \$250 on 7/3/2018

Number 3 – Part D - **\$22,000 in donation omitted from DoS report**

Michael Defeo - \$300 on 6/24/18

Wanda Nyce - \$600 on 6/25/18

W. David Rule - \$300 on 6/28/18

Glen Kraft - \$300 on 7/20/18

Dr. Jerome Marcus - \$500 on 9/22/18

Edward Cone - \$20,000 on 10/17/18

The two reports are attached for your information.

In addition, the reporting dates are not accurate in the Cycle 5 report that was submitted and is posted online with the Department of State.

*Cycle 5 should be inclusive of all contributions and expense between the reporting period June 5, 2018 through October 22, 2018.*

The Cycle 5 report submitted by the Friends of Mark M. Gillen includes the period September 18, 2018 through October 22, 2018. There does not seem to be an accounting nor a reporting of the contributions between June 5 and September 17, 2018.

We would appreciate your acknowledgement of this complaint and an expedited investigation into this time sensitive matter.
