



Good Government

The time is long overdue for Pennsylvania to have a government that serves all citizens of the commonwealth – and not just the special interests, said Doug Metcalfe, candidate for State Representative from the 128th District. “Since day one my campaign has been about Putting *People* Before Politics.”

Doug has announced specific measures designed to put *people* before politics and hold legislators accountable for their actions.

- Enact meaningful campaign finance reform
- Modernize the voting system

- Institute a NO Pay rule for Legislators if the state budget is not passed by June 30th
- End the lavish perks and benefits our elected officials receive during (*and* after office)

“It is time to wrestle control of our state government away from the special interests, big corporations and lobbyists and put it make in the heads of the *people* of Pennsylvania!” he said.

“My campaign is about fighting for hard working Pennsylvanians. My campaign is about protecting our seniors. My campaign is about working with our business owners and family farms to grow and develop our main streets and agricultural communities.”

“Government is for the people by the people. We need to hold our elected officials accountable and our government needs to be transparent. I am committed to ending the corruption, cronyism and special interests influence in our government,” Doug said.
